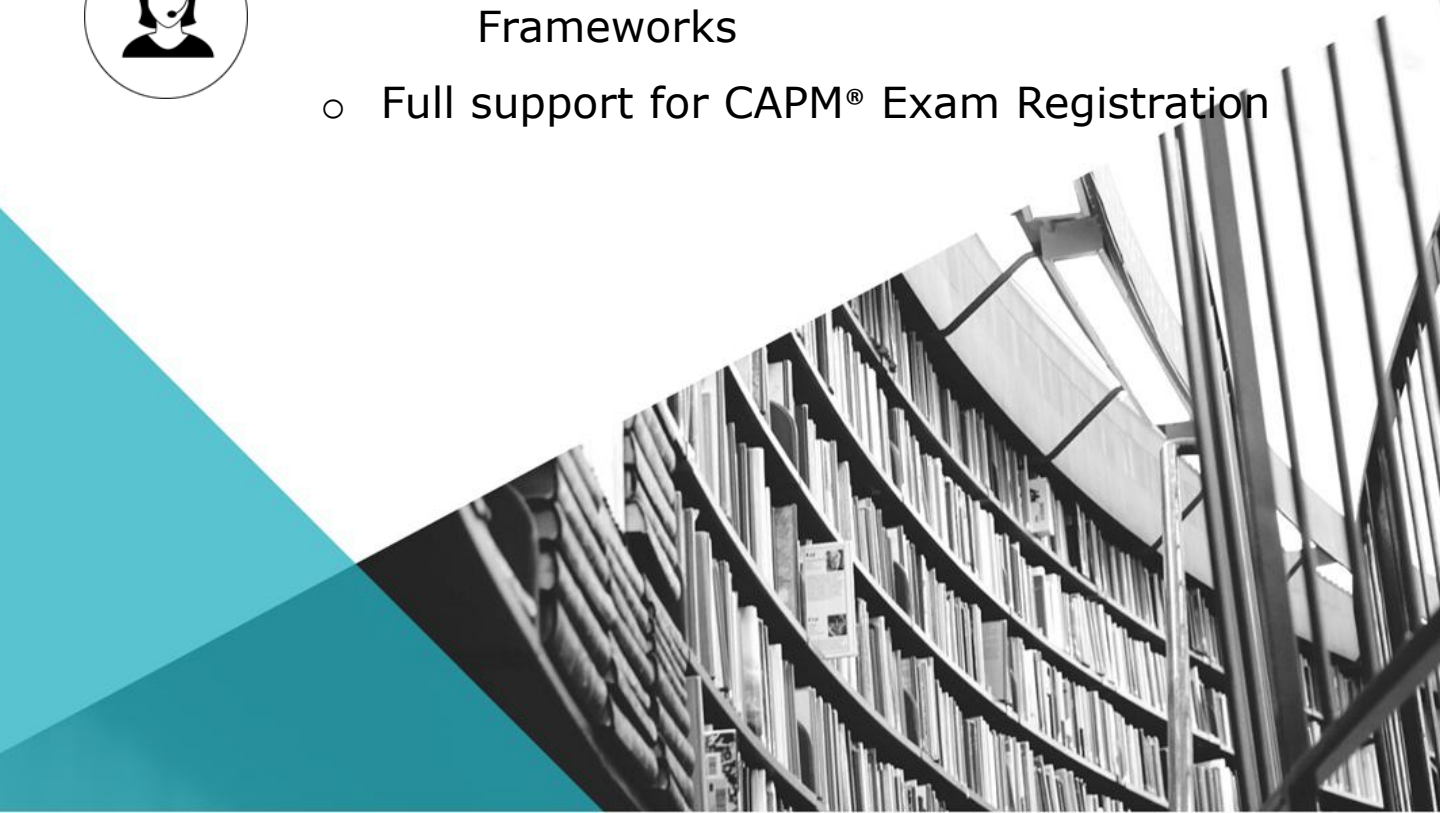

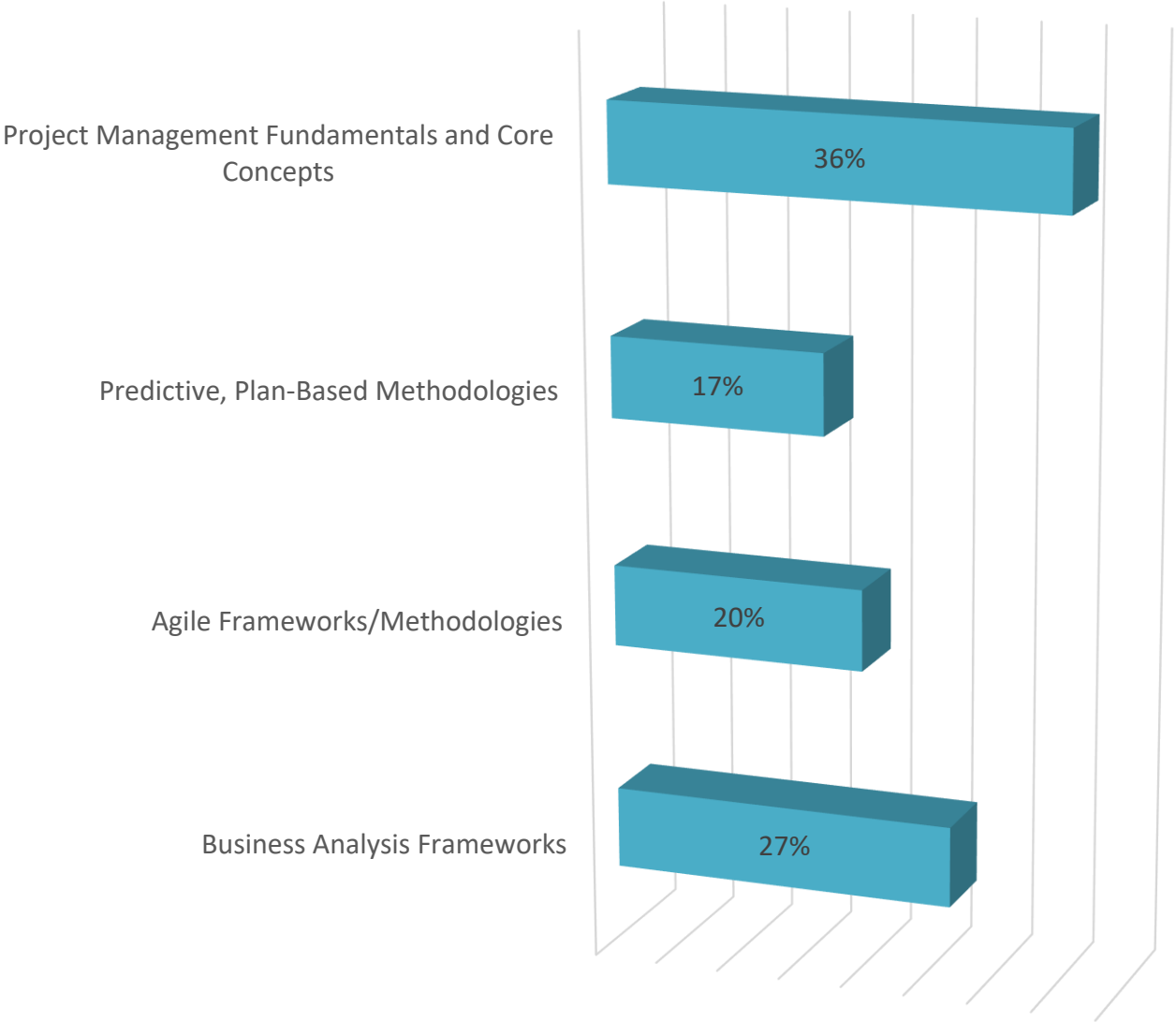

What are the CAPM® exam qualification requirements?

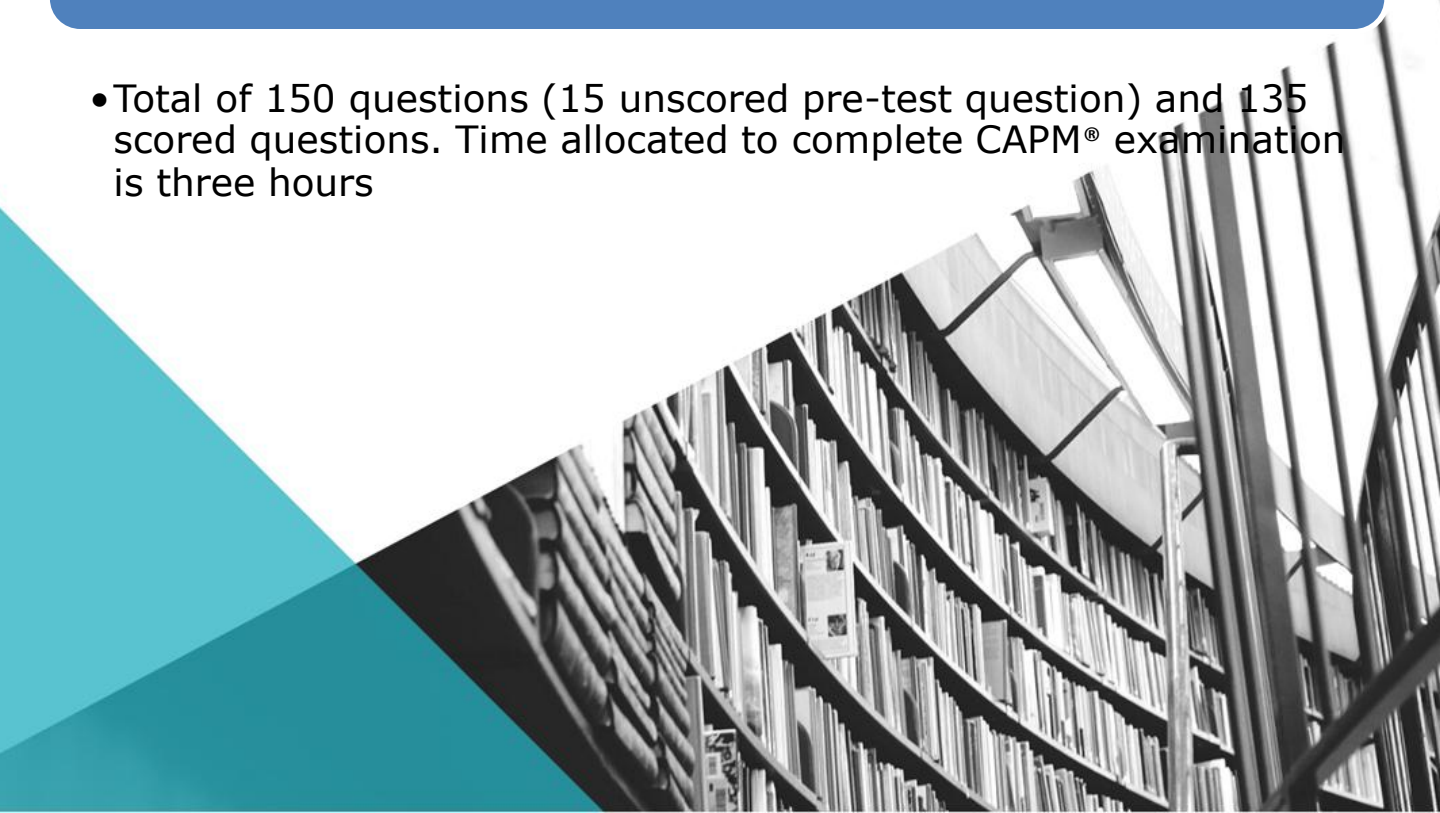
- Secondary degree (high school diploma, SPM, O-Levels, STPM, associate's degree or the global equivalent)
- 23 hours of project management education completed by the time you sit for the exam.

How much is the CAPM® examination fee?

- The CAPM® Examination fee is USD 300 (approx. RM 1,500). This fee can also be claimed together with the course fee for HRDCorp Claimable Course: SBL Khas

What is the CAPM® exam format?

- Total of 150 questions (15 unscored pre-test question) and 135 scored questions. Time allocated to complete CAPM® examination is three hours
